3/2/2020 Cleared location. Moved in equipment and rigged up. Rods were free. Laid down 85 $\frac{3}{4}$ " rods. Replaced wellhead connections and installed BOP. Laid down 68 joints 2 $\frac{3}{8}$ " tubing. SION

3/3/2020 Made gauge ring run to 1725' without issue. Set CIBP at 1710'. Tagged CIBP with tubing and circulated MLF. Tested casing to 550#. Casing good. Spot 50 sx Class C on top of CIBP. POOH to 444' and circulated cement to surface with 50 sx cement. Rigged down. Did not dig out due to rain.

3/5/2020 Dug out and cut off wellhead. Filled up both strings of casing with 15 sx cement. Installed marker, removed anchors, cleaned pit and moved out equipment.
