Current Status:

3/12/20 - Stage 1 of well was perforated and well is currently full of freshwater. Set a solid composite plug 4.30"OD 10K PSI Differential 200F Bridge plug (Model No: 55.P92A.430.MN1F) at 3,000' and tested plug to 9800 psi and held for 30 minutes, 3/13/20. 3/14/20 - Dump bailed 35' of cement on top of plug (TOC = 2,965'). Pressured up to 1000 psi on surface and held for 15 minutes. Installed back pressure valve in tubing hanger to secure the well.
3/15/20 - Well TA complete
