We lost returns immediately after drilling out the shoe of the surface casing. Because of this inability to circulate, a successful FIT test can't be performed. Mewbourne plans to continue drilling to 9 5/8" intermediate casing setting point at 3185' and cementing to surface. A FIT test will be performed after drilling out the intermediate casing shoe.
