Construction start-up is anticipated in May 2019, with equipment delivery anticipated in April 2019. This equipment will replace the staging area/laydown yard associated with the Central Delivery Point permit.

Cryo trains will include: amine treating units, mole sieve dehydration systems, and refrigeration units.

No injection wells are associated with this application.  
No additional surface disturbance is requested with this application.
