Oxy respectfully requests approval to temporarily suspend drilling operations for 6 months from the rig down date of 3/12/2020 due to current economic conditions related to the low price of oil.

Well history:

The Pure Gold 171H, 172H, 7H were planned and permitted as a 4 string 12.5k long lateral targeting the formations seen in the table above. These wells were successfully drilled down to the surface section TD's listed in the table above and cased off with 13-5/8" 54.5# J-55 BTC, and cemented to surface per plan.

Current status:

The 13-3/8" J-55 casing has been set and cemented per BLM approved APD. Casing shoes are set at depths depicted in table above. Cement was displaced with 8.33 ppg fresh water, and the shoe track is intact. The wells were capped and have pressure gauges on the caps. Wells are static.

Plan forward:

Drilling operations will be temporarily suspended and the wellbores will be left as is. Oxy will plan to return to the wells in approximately 9 months, pending economic conditions. Oxy will request additional shut-in status extension sundries and APD extensions as needed, once future completions plans are finalized.
