Also, the completion sundry gives the ETOC as 5580, but the 3160-4 gives it as surface (28'). - The correct TOC is 28'

Can I get you to clarify or correct one or the other of these (easiest would be completion sundry) so that our numbers match and there is no hang up getting your C-104 approved?

You can send me a clarification or corrected sundry (use the state form if you like) by return email. But which you correct is up to you, of course.
