Dear Mr. Lowe:

Included with this letter are the following documents demonstrating that the above referenced well has been drilled at a standard oil well location:

- As completed Plat dated May 12, 2020, showing the location of the Antero 14 Federal Com 705H;
- An "Area of Common Ownership Plat" separately showing the spacing unit for the well: and
- A Certification of Ownership demonstrating the outlined area on the plat is comprised of four federal leases, with uniform ownership.

19.15.16.15.C(7) NMAC provides that in area of common ownership (here, four federal leases) the setback requirements only apply to the outer boundary of the area of uniform ownership, not the spacing unit within the area of uniform ownership. Since the area to the east towards which this well encroaches is within the documented "area of common ownership," this well is at a standard location and approval of a non-standard location for the well is not necessary.




