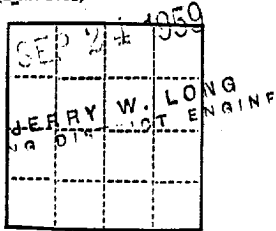

DETAILS OF WORK

We propose to drill to approximately 6000' to test the Pennsylvanian formation. We will check the San Andres, Glorietta and Yeso formations between approximately 1500' and 2800'. We will set approximately 350' of 13-3/8" 48# H-40 casing. We will also set, if necessary, approximately 2000' of 9-5/8" 32.3 H-40 casing. If commercial production is found, we will set 5-1/2" 15.5# J-55 casing as an oil string. We will circulate the 13-3/8" casing with cement.
