Run 2-3/8" tubing and circulate well with heavy mud. Spot 25 sacks of class H cement on top of cast iron bridge plug set at 2113'
Spot 25 sacks of class H cement across 8-5/8" casing shoe (appx. 590' to 780')
Spot 10 sacks of class H cement plug at surface. Weld on cap. Erect abandonment marker.
Fill pit, level location and clear area of junk.
