On 7-1-81 Aztec Drilling (Rig #50) spudded a 12-1/4" hole at 1:30 p.m. Drilled to a TD of 736' and ran 8-5/8" casing set at 736'. Cemented with 500 SX Class H cement. Plugged down 8:00 a.m. 7-2-81. Circulated 208 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2830' and ran 5-1/2" casing set at 2815'. Cemented with 1400 SX Class H cement. Plugged down 11:40 a.m. 7-8-81. Circulated 333 SX. Currently waiting on completion unit.
