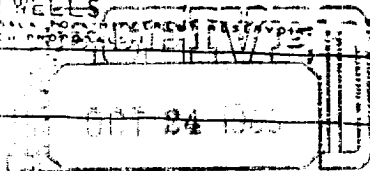

Circulated 114 sacks cement to reserve. Tested casing for 30 min. and ok. Logged and ran 7" casing and set at 2810'. Cemented with 1050 sacks Class H and additives. Plugged down at 11:30 a.m. on 10/3/83. Circulated 355 sacks cement to reserve. Pressure tested at 1000 psi for 30 min. and ok. Rig released at 2:00 p.m. on 10/3/83. Currently waiting on completion unit.
