- Commenced drilling operations (spudded) at 3:00 A.M. on June 26, 1959.
 - Ran and cemented nine (9) joints of 10-3/4 inch, J-55, 32.75#, casing in 13-3/4" hole. Cemented with 255 sacks Ideal Portland Cement mixed to 2% Calcium Chloride. Cement circulated to surface. Job Completed at 6:30 P.M. June 26, 1959.
- Cement was allowed to set 12 hours, casing was tested with 500 pounds water pressure for 30 minutes, held O.K. Drilling commenced under surface pipe (9-5/8 inch hole) at 7:00 P.M. on June 27, 1959. Total time allowed cement to set: 24-1/2 hours.
