On 9-23-83 Aztec Drilling Co. (Rig #171) spudded a 12-1/4" hole at 2:00 pm. Drilled to 725' and set 9-5/8" casing. Cemented with 375 sacks class H and additives. Circulated 157 sacks to pit and tested casing at 600 psi and OK. Plugged down at 10:30 am on 9-24-83. Logged and ran 7" casing and set at 2665'. Total depth is 2665' and was reached 9-26-83. Cemented with 700 sacks class H and additives. Plugged down at 3:00 pm on 9-27-83 and circulated 192 sacks to pit. Rig released at 5:00 pm on 9-27-83. Moved in completion unit 10-17-83. Perforated 2313'-16', 2318'-22', 2333'-50', 2358'-65', 2372'-84', 2387'-94', 2399'-2408', 2416'-32', 2450'-53', 2457'-58', 2483'-91', 2494'-99', 2502'-09', and 2530'-34' with 2 JSPF. Flow tested thru a separator at an average of 1609 MCFD for 172 hours. Shut in well 11-16-83.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
