On Friday April 17, 2015 at 3:45 MDT, at Leamex #8, a stuffing box leak was found during normal rounds resulting in a release of 5 bbl. of produced water and 3 bbl. of oil with 2 bbl. of produced water and 2.5 bbl. of oil recovered. The affected area will be remediated according to NMOCD and COPC guidelines. This is a Tier 3 event.
