
Please find enclosed one electronic copy (flash drive) of the above-referenced report prepared by Apex TITAN, Inc. (Apex). The report is associated with an historic spill of produced water due to a leak from a produced water line.

The activities detailed in the attached *Corrective Action Report (CAR)* include all activities completed at the site since March 2015. The activities include plugging and abandonment of monitoring well MW-1, remediation of chloride impacted soils, transportation and disposal of impacted soils to an approved landfill, installation of a poly liner in the excavation and backfilling of the excavation. Additional activities detailed in the CAR include a groundwater evaluation utilizing a Constant-rate Aquifer Testing and Recovery Test on monitoring well MW-2. Figures, photo documentation, aquifer test results, initial and final signed C-141's and the well plugging plan of operations is included in the CAR for your review.

Occidental Permian, LTD respectfully requests regulatory closure of the above listed site based on findings and determinations based on those findings as discussed and verbally agreed on by Occidental and NMOCD personnel during the June 23rd 2015 meeting.
