Please remind whoever is operating the brine well west of Hobbs for you, a C-103 Notice of Intent must be filed and approved with both the District 1 office in Hobbs and myself BEFORE workover operations begin. A subsequent C-103 Sundry Notice must also be filed after field operations detailing what actually occurred. At that point we can then make an objective and reasonable decision as to whether or not an MIT is necessary once the well is back in service.

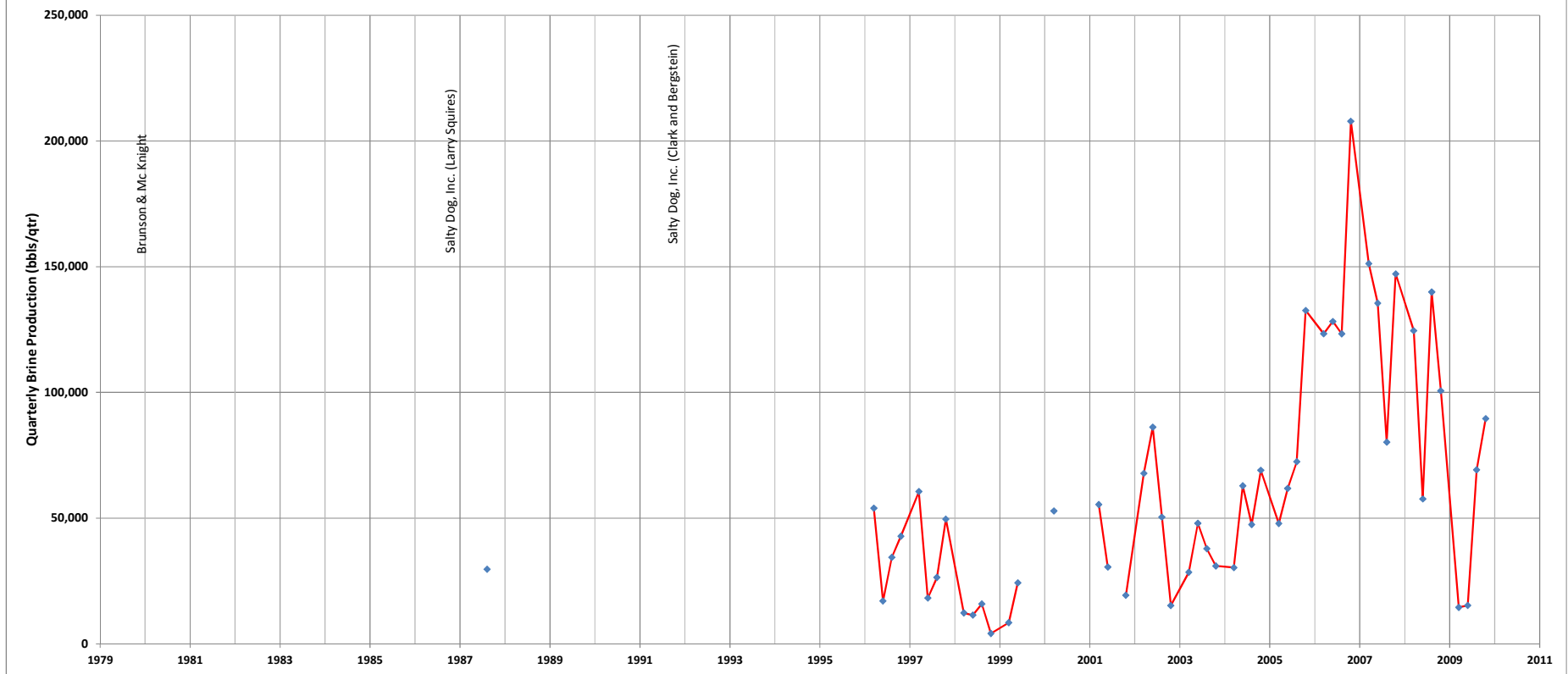
