Groundwater Elevation Correlation

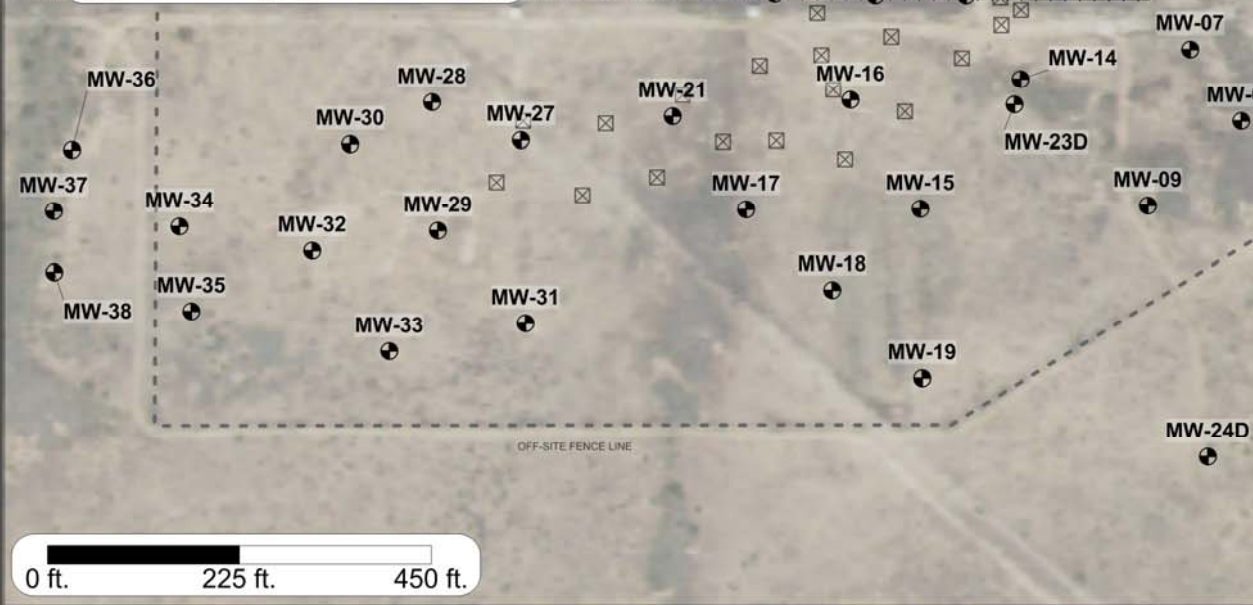

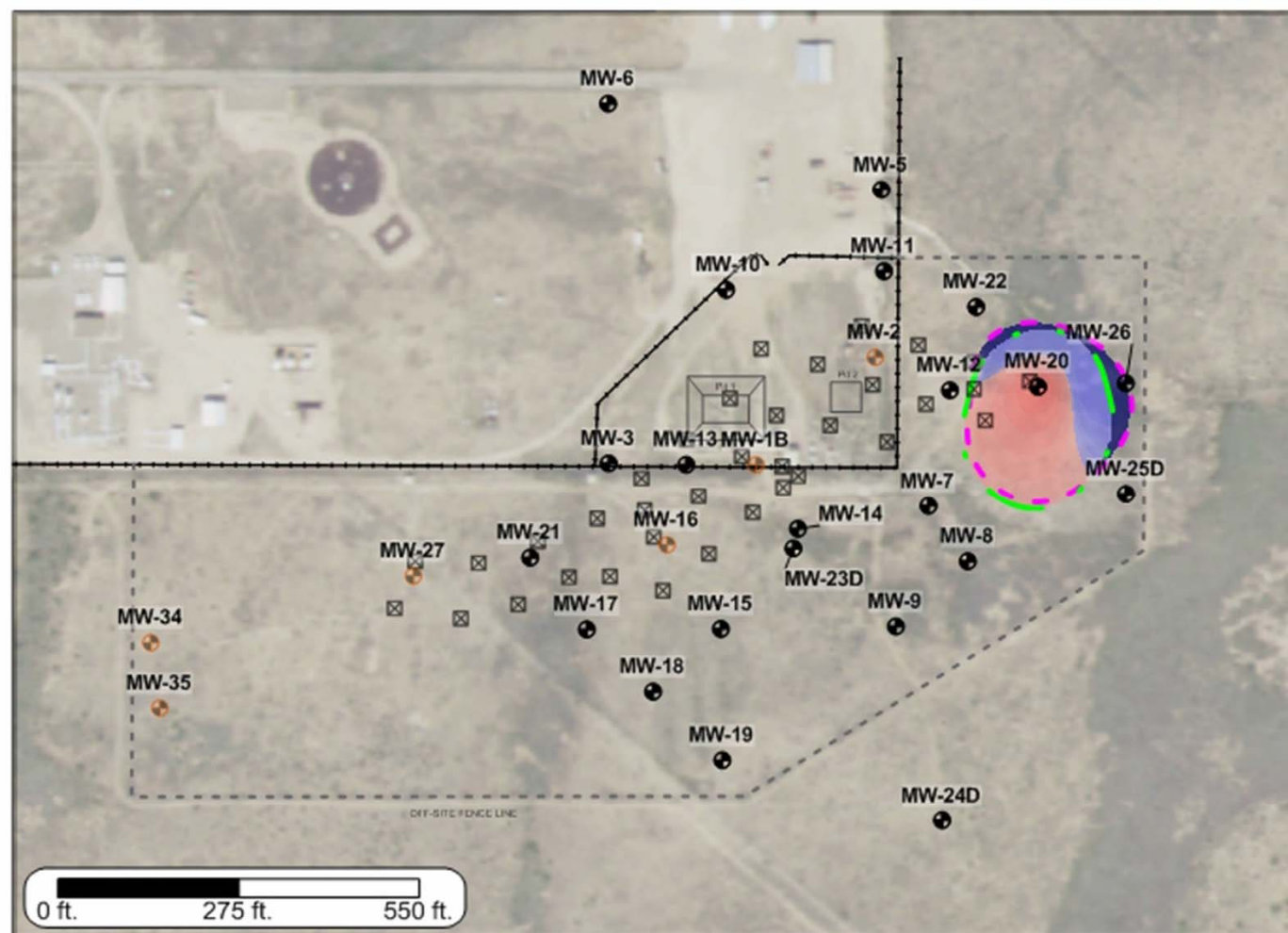


Concentration ($\mu\text{g/L}$)

Benzene Center of Mass

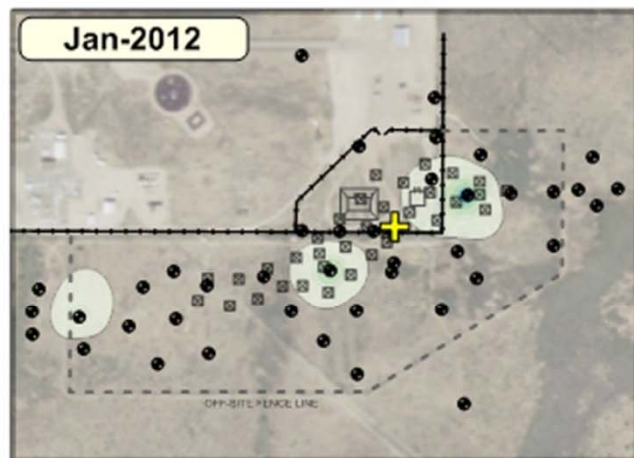

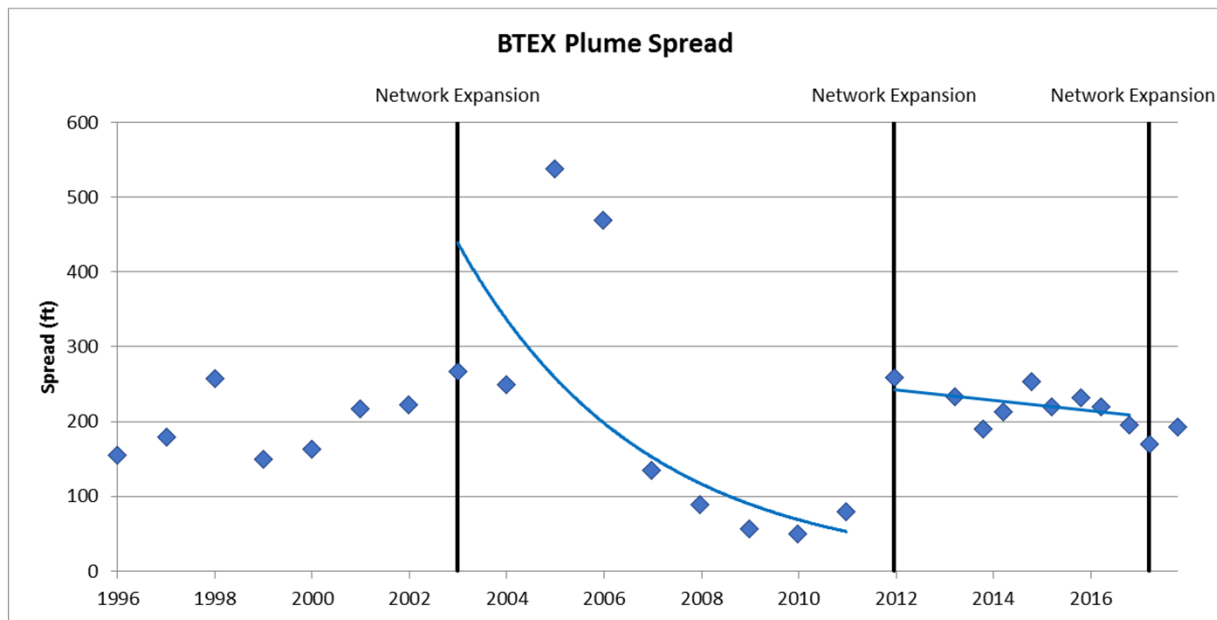
Groundwater Elevation Correlation



BTEX Center of Mass

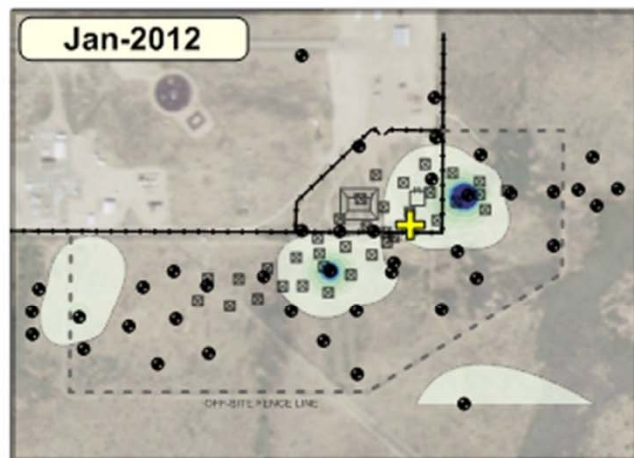

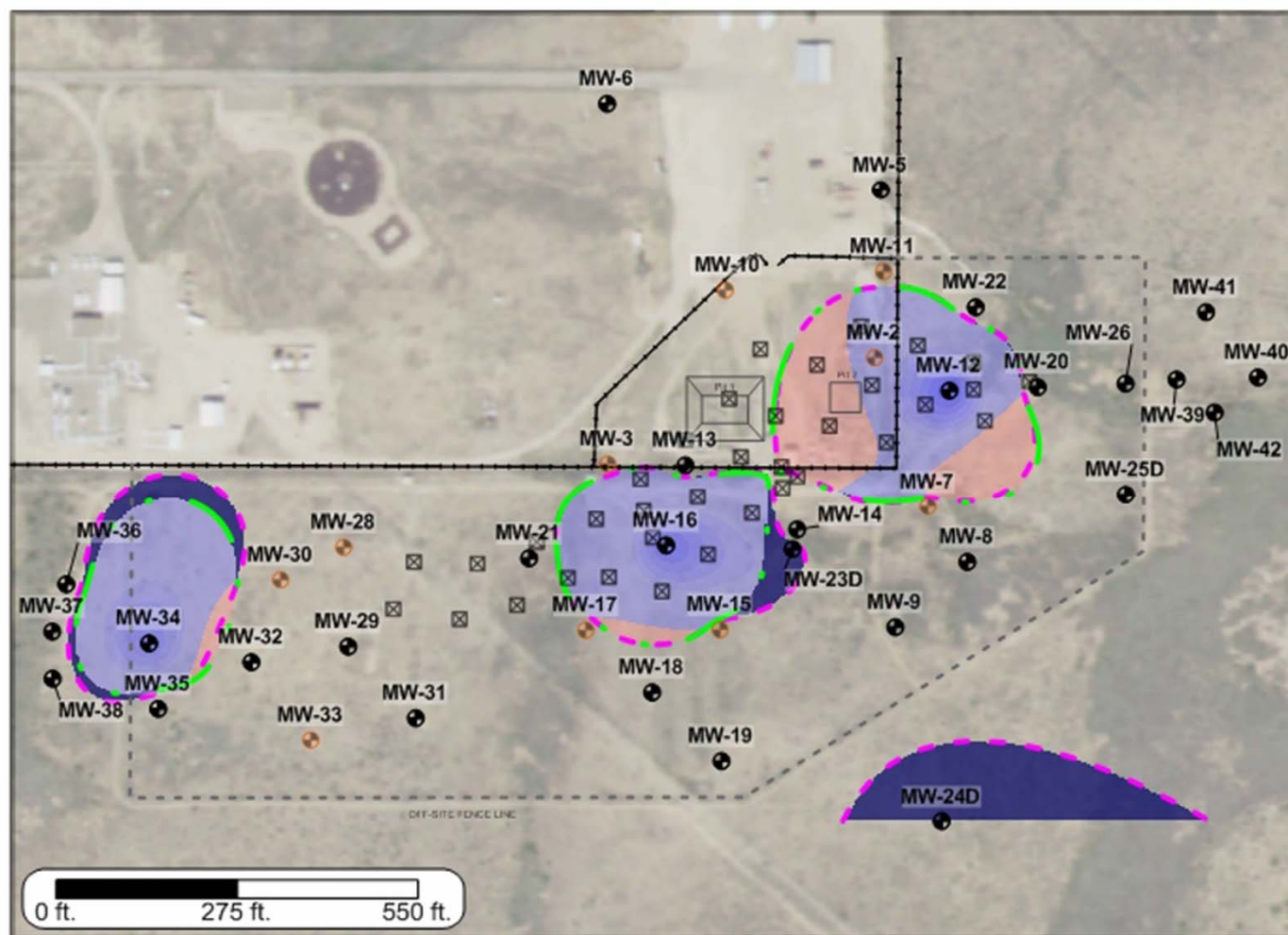


Concentration ($\mu\text{g/L}$)

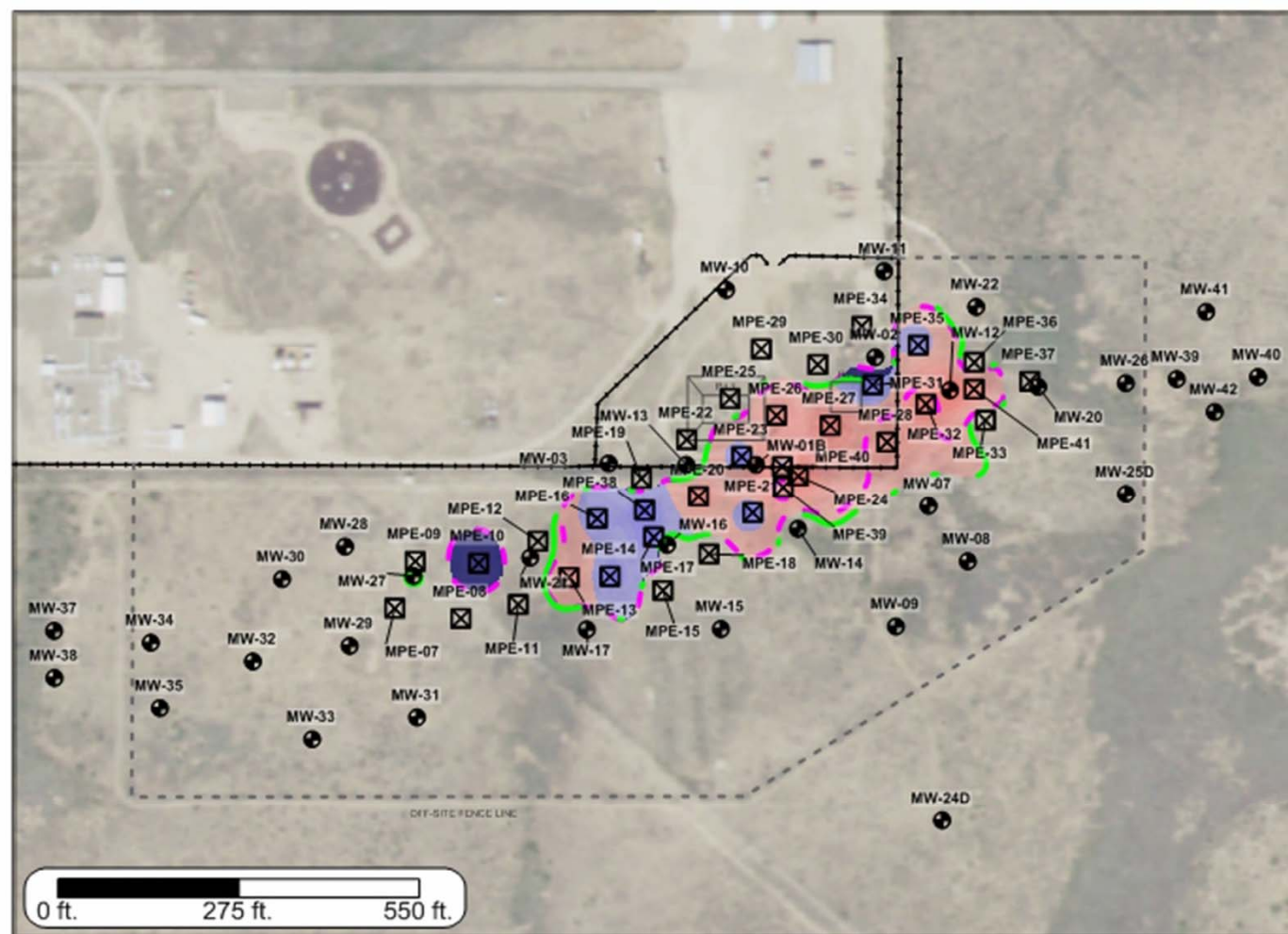


Concentration ($\mu\text{g/L}$)

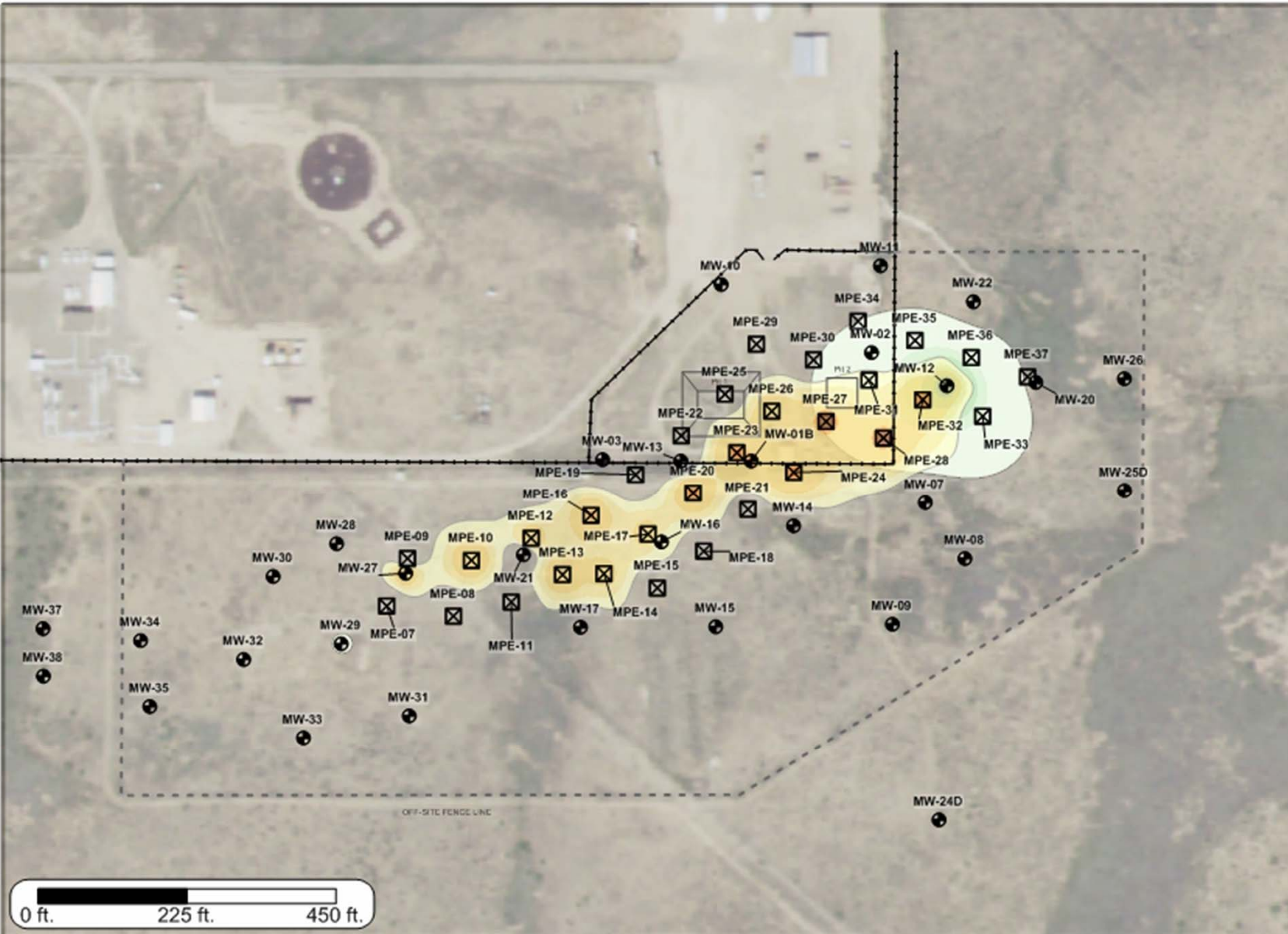
