(Andeavor/Marathon Oil Company) SANITARY LAGOON STATUS OF DISCHARGE

BRIEFING

Jim and I attended the meeting yesterday with NMED and the Andeavor/Western Staff (Marathon Oil Company on 10/1/2018). Joel Dougherty with EPA (E-mail: dougherty.joel@epa.gov) listened by telephone for the entire 3-hr. meeting.

You may recall William Bailey (Environmental Manager) with Andeavor/Western was the manager having knowledge of the lagoon discharge and was first in communication with OCD on the sanitary lagoon. He was replaced by Jessica O'Brien who led the meeting, but she is now leaving to another company location, and John Moore, P.E. is the new Gallup Andeavor/Western Environmental Manager. He was in attendance at the meeting.

Per your directive, OCD inquired into the status of the Sanitary Lagoon discharge? The response was the "discharge is still occurring and had not been stopped."

Jessica showed a map with the sanitary pipeline supposed to be routed from the change house, and other nearby sanitary effluent sources to the lift station, but indicated after hydro excavation, the pipeline was not present. They are having difficulty hiring a plumber to complete the "as built" construction of the pipeline to connect to the sanitary lift station, which pumps to the Sanitary Treatment Pond (STP-1). The "Change House" etc. contributes in addition to sanitary effluent from toilets, gray water from showers associated with refinery operations and the fire station. OCD inquired about any wastewater that could be prevented from discharge, and it was determined that staff could be directed to other toilets, but showers are a safety and operations issue, which Allen Hains (Andeavor/Western) did not recommend stopping. OCD recommended use only as required by emergency(ies).

Scott Crouch (Andeavor/Western Environmental Consultant) referenced the Area of Concern (AOC 35) Work Plan (WP) that was delivered to NMED at the meeting. Scott indicated the sanitary lagoon pipeline after trenching is at least 15 ft. bgl, and he did not indicate standing water was in the trench constructed along the side of the pipeline. In the WP, monitor wells were proposed along the transect of the pipeline to determine if GW inundated the pipeline. Andeavor/Western asked why NMED requested monitor wells? OCD responded to check for point sources of contamination or confirm Andeavor/Western's prior response that it was pre-existing GW contamination in the area. OCD indicated it would prefer to see the sanitary effluent line removed and checked for point sources from holes, staining, etc. Allen Haines (Andeavor/Western) indicated they want to abandon the pipeline in place because there are so many lines running through the pipeline transect. NMED is reviewing the AOC 35 WP, and is having Michiya evaluate. Apparently, AOC 35 is used to address NMED correspondence on the Sanitary Lagoon. Scott indicated from dye testing, dye was detected downgradient from point of application, but the source of leakage was still not known, there investigation occurred where they had

access due to pre-existing equipment, infrastructure, etc. Sources could be sumps, line leakage....? There is a leak near the truck load out rack.

John Moore recommended stationing a frack tank at the sanitary lagoon "end-of-pipe" to address the discharge, and said he would address this today (9/20). OCD requested notification when this is completed. John Moore asked if future OCD correspondence was forthcoming, and Carl indicated it is "very likely."

Currently, Andeavor/Western is working to address the most recent NMED letter with OCD input on the sanitary lagoon. Andeavor/Western briefly mentioned the Sanitary Lagoon in its meeting minutes.
