The NMOCD has reviewed the closure request for the COG Sebastian Federal Com #002H Battery (1RP-5180) (30-025-41666) release which occurred on 8/29/18. The available information indicates the requirements of 19.15.29 NMAC have been met and no further corrective action is required. NMOCD considers **1RP-5389** closed. However, this determination by the Oil Conservation Division does not relieve Operator of responsibility should future information indicate a threat to ground water, surface water, human health, or the environment. Furthermore, it does not relieve Operator of responsibility for compliance with any federal, state, or local laws and/or regulations.
