Please find attached the *Site Assessment Report and Proposed Remediation Plan* that has been prepared for Vanguard's State V Tank Battery Site. Also attached is the original initial C-141 and EPI's 2017 Workplan, which was never submitted and or approved. As discussed, a majority of the impacted soil affected above the NMOCD Closure Criteria/NMOCD Reclamation Standard has been excavated and transported under manifest to an NMOCD-permitted disposal facility. We are still waiting for analytical results from several soil samples, but I believe I had enough data to go ahead and prepare a *Site Assessment and Proposed Remediation Plan* in accordance with the new spill rule.
