ConocoPhillips Company (ConocoPhillips) respectfully submits the Closure request for your review and approval.

**Release summary**

The War Hammer Tank Battery is located in Unit A, Section 25, Township 26S, Range 32E, Lea County, more specifically in the following Coordinates: **Lat: 32.01527, Long: -103.62472**. As reported on the C-141, on March 3, 2019, 90 bbls of produce water were release but contained inside the lined secondary containment, all 90 bbls were recovered, and location cleaned with pressure wash on 5/13/19.

**Release Assessment**

Based on the spill location being inside the lined secondary containment (with excellent liner integrity), the immediate recovery of the total volume, and subsequent clean up of the lined containment, there is no further need for sampling or invasive work on location.

**Conclusion**

ConocoPhillips respectfully submits the Closure request for your review and approval, C-141 is enclosed on the attachment.


## Closure
