As per my voice mail on 3/14/19, we had a release at the Gissler B 3-3 TB. The release was caused when the extremely high winds broke the water leg on the gun barrel. This released approx. 690 BBLS of total fluid, and we were able to recover approx. 505 BBLS of total fluid. The majority of the release was contained within the bermed area of the facility. The facility has a liner on the South portion, where the heater treaters, separators, and FWKO are located. The wind did cause some an overspray area to the NNE, across the lease road and the Gissler B 20 well location. These areas will be scraped to remove any staining.
