RE: Transfer of Surface Waste Management Facility Permit NM1-61

Messrs. Karger and Brandt,

On February 4, 2021 the Oil Conservation Division (OCD) received a request from CK Disposal to transfer Permit NM1-61 to Urenco USA for a planned commercial surface waste management facility to be located east of Eunice, New Mexico within the Northern ½ of Section 5 in Township 22 South, Range 28 East NMPM. Pursuant to 19.15.36.12(E) NMAC, the officers, directors, and owners of 25% or more of Urenco USA have been identified, and Urenco USA has also provided replacement financial assurance in the proper form and amount. Accordingly, the OCD approves the transfer of Permit NM1-61.

As the new facility operator, Urenco USA is responsible for the actions of its officers, employees, consultants, contractors, and subcontractors as they relate to the operation of the facility and shall comply with 19.15.36 NMAC and all permit conditions. The permit will expire on May 25, 2027 unless Urenco USA submits an application for renewal no later than 120 calendar days before the expiration date.

SECRETARIAL CERTIFICATION

I, Brandt Graham, am Secretary of Urenco USA Energy Services, LLC (“UUES”), a Delaware Corporation with its place of business at 275 Hwy. 176, Eunice, New Mexico 88231, and in that capacity CERTIFY AS FOLLOWS:

Urenco USA Energy Services, LLC (“UUES”) is a Delaware limited liability corporation formed on December 30, 2010 to engage in all lawful businesses for which limited liability companies may be organized. Ms. Karen D. Fili is the President and CEO of UUES, as well as Manager on the UUES Board of Managers. UUES has no ownership of any subsidiary entities, and no divisions.

The ownership of UUES is as follows:

UUES is wholly-owned by Urenco USA, Inc. (“UUI”) (a Delaware corporation and wholly-owned subsidiary of Urenco Limited, a company formed under the laws of England (“Urenco”) and owned in equal shares by Enrichment Investments Limited (“EIL”), Uranit UK Limited (“Uranit”), both companies formed under English law, and Ultra-Centrifuge Nederland NV (“UCN”), a company formed under Dutch law. EIL is ultimately wholly-owned by the government of the United Kingdom; UCN is ultimately wholly-owned by the government of the Netherlands; Uranit is ultimately owned by Eon Kernkraft GmbH (50%) and RWE Power AG (50%), companies formed under the laws of the Federal Republic of Germany). As the sole member of UUES, UUI holds all or 100% of the UUES membership units and all or 100% of the UUES member voting power. Karen D. Fili is the President of UUI and is also the Chair of the UUI Board of Directors.

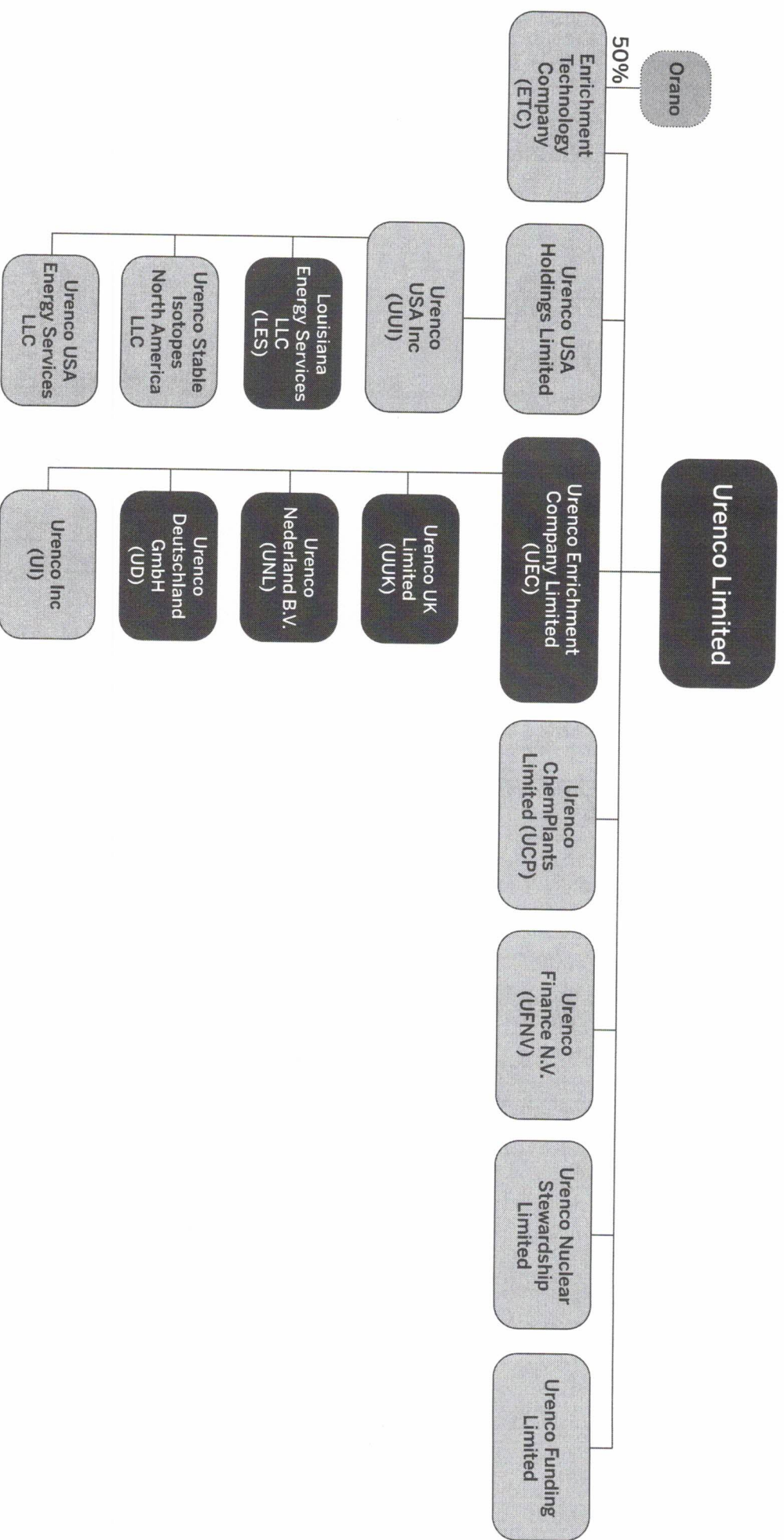


