Ground water is estimated to be less than 25 feet below ground surface. The facility contains 5 tanks with various amounts of hydrocarbon wastes, one tanker trailer, and oil spills from leaking tanks have saturated the ground all around the tanks.

Plan: The next step is to notify the owners that an investigation and cleanup is required for the facility. If that route dead ends the order must be revoked by the Division so that the OCD can perform the investigation and cleanup. The scope of work would include investigation and cleanup to remove the tanks, pit contents, remove surface contamination and investigate the groundwater below the site.


