Dear Mr. Fothergill:

The Oil Conservation Division (OCD) has received your request for a renewable five year authorization to discharge hydrostatic test waters.

Based on the information and commitments, authorization is hereby approved with the following conditions:

- 1. This permit is for testing new pipe only. All used pipe tests must receive specific discharge approval from the OCD prior to testing. Used pipe is defined as any pipe or section of pipe that has had any hydrocarbons in contact with its walls.
- 2. Only fresh water (preferably less than 2,000 mg/l total dissolved solids) shall be used in hydrostatic testing.
- 3. The volume of test water cannot exceed 100,000 gallons. All tests involving more than 100,000 gallons must receive authorization from the OCD on a case by case basis.
- 4. No test waters will be discharged to any lakes, perennial streams, rivers, or any surface bodies of water upon completion of a test.

- 5. A report must be filed every twelve months summarizing the activities and shall contain. the following information:
 - Α. Location of test - Section, Township and Range
 - B. Date of test.
 - C. Volume of discharge.
 - D. Source of test water.

The approved discharge authorization consists of the original permit dated November 2, 1989 and the renewal request.

The request for discharge authorization was submitted pursuant to New Mexico Water Quality Control Commission Regulations and is approved pursuant to that regulation.

This authorization is approved for a period of five (5) years. The authorization will expire October 31, 1999.

Please be advised that this approval does not relieve you of liability should your operation result in actual pollution of surface water, ground water, or the environment actionable under other laws and/or regulations. In addition, the OCD approval does not relieve you of liability for compliance with other laws and/or regulation.

RE: Discharge of Hydrostatic Test Waters

Dear Mr. Fathergill:

The Oil Conservation Division (OCD) has received and evaluated your request, dated October 19, 1989, for a renewable five year authorization to discharge hydrostatic test waters.

Based on the information provided in your request, the authorization is hereby approved with the following conditions:

- 1. This permit is for testing newly constructed pipe only. All used pipe tests must receive individual discharge approval from the OCD prior to testing. Used pipe is defined as any pipe or section of pipe that has had any hydrocarbon in contact with its walls.
- 2. The volume per test does not exceed 100,000 gallons.
- 3. The tests follow the procedures as proposed in your October 19, 1989 request. Since the testing will utilize a closed-loop system and water will be entirely self-contained, the provisions of the hydrostatic test guidelines pertaining to anticipated discharges will pertain to leaks in the tested pipe:
 - a) No discharge due to any leak may enter any lake, perennial stream, river or their respective tributaries that may be seasonal.
 - b) Ground water may not be less than 10 feet from the surface at any point of discharge.
 - c) No discharge may impact adjacent property.

- d) No discharge may cause any fresh water supplies to be degraded or to exceed standards as set forth in Section 3-103A, B, and C of the New Mexico Water Quality Control Commission Regulations.
- 4. A monthly report, summarizing all tests of new pipe with less than 100,000 gallons each, will be submitted to the OCD and shall contain the following information.
 - a) Location of test-Section, township and Range;
 - b) Date of test;
 - c) Volume of test water;
 - d) Source of test water;
 - e) Leaks detected and action taken to contain and recover the test water.
- 5. In the event a leak in the new pipe occurs such that conditions 3(a) (d) above are not met, OCD shall be notified and a spill report submitted.
- 6. Precautions shall be taken at the pipeline entry and exit points to prevent spillage of produced water on the surface of the ground. Spills not meeting the conditions 3(a) (d) above shall be reported to OCD.

The approved discharge authorization consists of the request dated October 19, 1989.

The request for discharge authorization was submitted pursuant to Section 1-201 of the New Mexico Water Quality Control Commission Regulations and is approved pursuant to that regulation.

Please be advised that the approval of this plan does not relieve you of liability should your operation result in actual pollution of surface of ground waters which may be actionable under other laws and/or regulations.

This authorization is approved for a period of five (5) years. The authorization will expire October 31, 1994 and you should submit an application for renewal fin ample time before that date.
