The Oil Conservation Division (OCD) has received your request, dated January 22, 1993, for a renewable five year authorization to discharge hydrostatic test waters.

Based on the information and commitments, authorization is hereby approved with the following conditions:

1. This permit is for testing newly constructed pipe only. All used pipe tests must receive discharge approval from the OCD prior to testing. Used pipe is defined as any pipe or section of pipe that has had any hydrocarbon in contact with its walls.
2. The volume per test does not exceed 100,000 gallons.

The approved discharge authorization consists of the request dated January 22, 1993.



Re: Renewal of Hydrostatic Test Waters Discharge Permit (HBP-NM-009)

Dear Mr. Gawlik:

The New Mexico Oil Conservation Division (OCD) has received Sid Richardson Gasoline Co. request dated January 12, 1998 for a renewable five year authorization to discharge hydrostatic test waters.

Based on the information and commitments provided, authorization is hereby **approved** with the following conditions:

1. This permit is for testing new pipe only. All used pipe tests must receive specific discharge approval from the OCD prior to testing. Used pipe is defined as any pipe or section of pipe that has had any hydrocarbons in contact with its walls.
2. Only fresh water (preferably less than 2,000 mg/l total dissolved solids) from a water supply system or other potable source shall be used in hydrostatic testing.
3. The volume of test water cannot exceed 100,000 gallons. All tests involving more than 100,000 gallons must receive specific authorization from the OCD prior to testing.
4. No test waters will be discharged to any lakes, perennial streams, rivers, or any surface bodies of water or their respective tributaries that may be seasonal.
5. Ground water is not less than 10 feet from the surface at the point of discharge.
6. The Discharge does not impact adjacent property.

7. The discharge does not cause any freshwater supplies to be degraded or to exceed standards as set forth in Section 3103A, B and C of the New Mexico Water Quality Control Commission Regulations.
8. A report must be filed every twelve months summarizing all tests of new pipe with less than 100,000 gallons each. The report will be submitted to the OCD and shall contain the following information:
 - A. Location of test - Section, Township and Range
 - B. Date of test.
 - C. Volume of discharge.
 - D. Source of test water.


The request for discharge authorization was submitted pursuant to New Mexico Water Quality Control Commission Regulations and is approved pursuant to that regulation.

This authorization is approved for a period of five (5) years. The authorization will expire January 22, 2003.

Please be advised that this approval does not relieve Sid Richardson Gasoline Co. of liability should their operation result in pollution of surface water, ground water, or the environment. In addition, OCD approval does not relieve Sid Richardson Gasoline Co. of liability for compliance with other laws and/or regulation.

Hydrostatic Test Water Discharge Permit Application

Dear Mr. Anderson:

Sid Richardson Carbon & Gasoline Co. is in the process of installing a new six (6) inch products pipeline at the Jal #3 New Mexico gas processing facility. A hydrostatic test of the pipeline will be conducted prior to operation.

This letter serves as an application for the issuance of a renewable five (5) year discharge permit for hydrostatic test water. The following is offered in support of our application:

- 1) The water volume for the test is estimated to be 27,000 gallons.
- 2) Fresh water from the Jal #3 well water supply system will be used for the test.
- 3) The discharge will not find its way to any lake, perennial stream, river or tributary.
- 4) Ground water at the discharge point is far below the ten (10) foot surface limitation.
- 5) The discharge will take place solely on Sid Richardson property.

- 6) No fresh water supplies will be affected.
- 7) Sid Richardson will provide a semi-annual report to OCD which summarizes all hydrostatic tests of new pipeline. In addition to adhering to the conditions described above, the report will also contain:
 - a) Location of test - section, township, range
 - b) Test date
 - c) Discharge volume
 - d) Test water source and quality

A report will be submitted whether or not any tests have been conducted during the reporting period. If no tests have been conducted, the report will contain a statement to that effect.

If this application is approved, please send the discharge permit to my attention at the letterhead address, Suite 3000.
