

On January 2, 1998, SRGCo. submitted to the OCD a request for the renewal of our current five-year authorization for the discharge of hydrostatic test waters in Lea County, New Mexico. As per our telephone conversation on January 26, 1998, you requested that an annual statement be sent to you for all new pipe that was hydrostatic tested for the years 1995, 1996 and 1997. The following is furnished for your records:

1995 - No new pipe was hydrostatic tested in 1995.

- 1996 Two (2) tests were conducted in February 1996, and a total of 107,900 gallons of fresh water were discharged onto the ground.
 - **Test 1** Section 24, TS 25S, Range 33E. Discharged 37,900 gallons of fresh water.
 - Test 2 Section 25, TS 25S, Range 33E. Discharged 70,000 gallons of fresh water.
- 1997 One (1) test was conducted in October 1997, and a total of 30,027 gallons of fresh water discharged onto the ground.
 - Test 1 Section 2, TS 25 S, Range 31E. Discharged 30,027 gallons of fresh water.
