Dear Mr. Anderson:

Conoco Inc. requests renewal of Hydrostatic Test Water Discharge Permit # HBP-NM-015. The proposed discharges would occur from new piping in and around Southeast New Mexico, and in the vicinity of Farmington and Gallop, New Mexico. We understand that this authorization will be for test water discharges < 100,000 gallons from new pipe only and that the following additional conditions will apply:

- Fresh water only will be used as test media.
- No test water will be discharged to any lakes, perennial streams, rivers or any surface bodies of water upon completion of test.
- An annual report will be filed with the OCD for all discharges accomplished under this permit describing: location of test, date of test, volume of water discharged, and source of test water.
- The duration of each discharge cannot exceed 120 days.

We also understand that no analytical requirements apply to discharges accomplished under this permit. Please advise if there are any other requirements that must be met for coverage under this permit. Enclosed is a \$100 application fee for the permit renewal. 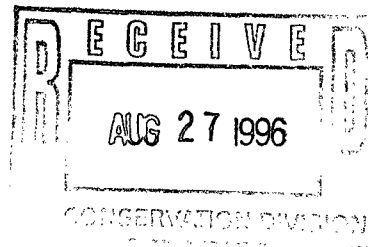

for New Pipe (5 year permit) -
Conoco Inc.**

Dear Mr. Eustice:

We are requesting a 5 year hydrostatic discharge permit for discharges that are less than 100,000 gallons from new pipe. These discharges would occur from new piping put in near the following gas plants: Maljamar Gas Plant in Maljamar, N.M., San Juan Gas Plant in Farmington, N.M., and the Wingate Gas Plant in Gallup, N.M. It is understood that this permit would apply to discharges of less than 100,000 gallons from new pipe, using fresh water. As a result, no analytical is required, but an annual report must be submitted which states the volume and location of the discharges. Please clarify if there are any other requirements that must be met as part of the permit condition.
