The Oil Conservation Division (OCD) has received the EOTT Energy Pipeline Limited Partnership (EOTT) request, dated May 22, 1997, for authorization to discharge approximately 168,000 gallons of waste water from the hydrostatic test of a section of new pipeline (8" line). The proposed location for the discharge is EOTT's Loco Hills Station within the new tank dike located in Section 34, Township 17 South, Range 32 East, NMPM, Lea County, New Mexico.

Based on the information provided in your request, the hydrostatic test water discharge is hereby approved subject to the following conditions:

1. Permission will be obtained from the landowner(s) prior to discharge.
2. The test water will be discharged in a manner to prevent erosion.
3. The pipe must be new and never previously used for oil and/or gas transmission.
4. Fresh water will be used to conduct the test.
5. No discharged fluids will be allowed to enter a water of the U.S.



3. The pipe must be new and never previously used for oil and/or gas transmission.


