Dear Mr. Anderson:

El Paso Natural Gas Company (EPNG) plans to conduct hydrostatic tests on a section of pipeline (No. 1004) near Anthony, New Mexico. After the pressure test with fresh water, EPNG plans to dewater the pipeline into the partially backfilled excavation ditch to allow for safe settling of the pipe.
