
- Description of pipeline:
 62,400' of 10'' new natural gas pipeline in Eddy County as drawn out on the enclosed map. No pollutants are expected due to the use of new steel pipe with no internal coating or chemicals added to source water.
- 3. Source of water: Source will be from Johnson Water Station. This is potable water.
- 4. No Chemicals to be added.
- 5. Test dates: 11-08-97 thru-11-09-98.
- 6. Volume of test waters: Approximately 271,000 gallons Discharge rate: 200 gpm.
- 7. Location: Section 13 Township 23 S. Range 29 E. From Carlsbad go South on highway 285 until you reach highway 31. Turn left go approximately 6 miles to highway 128. Turn right on 128 and go approximately 5 miles to paved road. Turn right pavement ends in approximately ½ mile. It then becomes a caliche road. Go 2 miles to de-water area.
- 8. See enclosed map.

- 9. The water will be discharged through two, two inch valves which will cause sufficient turbulence for reoxygenation. Filtering through hay bales at the point of discharge should prevent erosion and keep suspended solids or other materials from leaving the site. The water will be discharged onto land pasture land, and will not reach any surface waters .
- 10. No pits or frac tanks will be used to store discharged water.
- 11. The landowner has been notified by B&H Maintenance & Construction, Inc. and by UPR Highlands. State Land
- 12. N/A
- 13. I certify that no test water will reach surface waters of the state.
- 14. I certify that I am authorized to make this application and that this application was prepared by me or under my supervision and direction, and that the data and facts stated herein are true, correct and complete to the best of my knowledge.






