The ground water discharge plan renewal GW 188-3 for the Enterprise Products Operating, L.P. (Enterprise) Hart Canyon #3 Compressor Station located in the NE/4 of Section 8, Township 31 North, Range 9 West, NMPM, San Juan County, New Mexico, is hereby approved under the conditions contained in the enclosed attachment. Enclosed are two copies of the conditions of approval. Please sign and return one copy to the New Mexico Oil Conservation Division (NMOCD) Santa Fe office within 10 working days of receipt of this letter.

The discharge plan renewal application letter, dated June 10, 2005, submitted pursuant to Section 3106 of the New Mexico Water Quality Control Commission (WQCC) Regulations also includes all earlier applications and all conditions later placed on those approvals. The discharge plan is renewed pursuant to Section 3109.C. Please note Section 3109.G, which provides for possible future amendment of the plan. Please be advised that approval of this plan does not relieve Enterprise of responsibility should operations result in pollution of surface water, ground water or the environment. Nor does it relieve Enterprise of responsibility to comply with any other governmental authority's rules and regulations.

Please be advised that all exposed pits, including lined pits and open tanks (exceeding 16 feet in diameter) shall be screened, netted or otherwise rendered non-hazardous to wildlife including migratory birds.

Please note that Section 3104 of the regulations provides: "When a plan has been approved, discharges must be consistent with the terms and conditions of the plan." Pursuant to Section 3107.C, Enterprise is required to notify the Director of any facility expansion, production increase or process modification that would result in any change in the discharge of water quality or volume.

Pursuant to Section 3109.H.4, this renewal plan is for a period of five years. This renewal will expire on August 3, 2010, and Enterprise should submit an application in ample time before this date. Note that under Section 3106.F of the regulations, if a discharger submits a discharge plan renewal application at least 120 days before the discharge plan expires and is in compliance with the approved plan, then the existing discharge plan will not expire until the application for renewal has been approved or disapproved. It should be noted that all discharge plan facilities will be required to submit the results of an underground drainage testing program as a requirement for discharge plan.

The discharge plan renewal application for the Enterprise Hart Canyon #3 Compressor Station is subject to WQCC Regulation 3114. Every facility submitting a discharge plan application will be assessed a filing fee of \$100. There is a renewal flat fee assessed for gas compressor station facilities with horsepower rating greater than 3,000 horsepower of \$1,700.

Non-exempt oilfield wastes that are non-hazardous may be disposed of at an NMOCD approved facility upon proper waste determination per 40 CFR Part 261. Any waste stream that is not listed in the discharge plan will be approved by NMOCD on a case-by-case basis.
- 4. <u>Drum Storage:</u> All drums containing materials other than fresh water must be stored on an impermeable pad with curbing. All empty drums will be stored on their sides with the bungs in and lined up on a horizontal plane. Chemicals in other containers such as sacks or buckets will also be stored on an impermeable pad and curb type containment.
- 5. <u>Process Areas:</u> All process and maintenance areas which show evidence that leaks and spills are reaching the ground surface must be either paved and curbed or have some type of spill collection device incorporated into the design.
- 6. <u>Above-Ground Tanks:</u> All above-ground tanks which contain fluids other than fresh water must be bermed to contain a volume of one-third more than the total volume of the largest tank or of all interconnected tanks. All new tanks or existing tanks that undergo a major modification, as determined by the Division, must be placed within an impermeable bermed enclosure.
- 7. <u>Above-Ground Saddle Tanks:</u> Above-ground saddle tanks must have impermeable pad and curb type containment unless they contain fresh water or fluids that are gases at atmospheric temperature and pressure.

- 9. <u>Below-Grade Tanks/Sumps</u>: All below-grade tanks, sumps, and pits must be approved by the NMOCD prior to installation or upon modification and must incorporate secondary containment and leak-detection into the design.

- 10. <u>Class V Wells</u>: No Class V wells that inject non-hazardous industrial wastes or a mixture of industrial wastes and domestic wastes will be closed unless it can be demonstrated that groundwater will not be impacted in the reasonably foreseeable future. Leach fields and other wastewater disposal systems at NMOCD-regulated facilities which inject non-hazardous fluid into or above an underground source of drinking water are considered Class V injection wells under the EPA UIC program. Class V wells that inject domestic waste only must be permitted by the New Mexico Environment Department.
- 11. <u>Housekeeping:</u> All systems designed for spill collection/prevention will be inspected weekly and after each storm event to ensure proper operation and to prevent overtopping or system failure. A record of inspections will be retained on site for a period of five years.

A written commitment to comply with the terms and conditions of the previously approved discharge plan must be submitted by the purchaser and approved by the NMOCD prior to transfer.
- 14. <u>Storm Water Plan:</u> The facility will have an approved storm water run-off plan.
- 16. <u>Closure:</u> The NMOCD will be notified when operations of the Hart Canyon #3 Compressor Station are discontinued for a period in excess of six months. Prior to closure of the Hart Canyon #3 Compressor Station, the operator will submit a closure plan for approval. Closure and waste disposal will be in accordance with the statutes, rules and regulations in effect at the time of closure.
- 17. <u>Conditions accepted by:</u> Enterprise, by the officer whose signature appears below, accepts this permit and agrees to comply with all terms and conditions contained herein. Enterprise further acknowledges that the Division for good cause shown as necessary to protect fresh water, human health and the environment may change these conditions and requirements of this permit administratively.

The New Mexico Oil Conservation Division (OCD) has received EPFS letter dated June 10, 1996 requesting the addition of a 500 gallon steel lubricating oil storage tank at the Hart Canyon No.1 (GW-188-1) and the Hart Canyon No. 3 (GW-188-3) compressor stations. The EPFS request is considered a minor modification to the above referenced discharge plan and public notice will not be issued. The requested minor modification is hereby approved, with the following conditions:

- 1. Above Ground Tanks: All above ground tanks which contain fluids other than fresh water must be bermed to contain a volume of one-third more than the total volume of the largest tank or of all interconnected tanks. All new facilities or modifications to existing facilities must place the tank on an impermeable type pad.
- 2. Above Ground Saddle Tanks: Above ground saddle tanks must have impermeable pad and curb type containment unless they contain fresh water or fluids that are gases at atmospheric temperature and pressure.
- 3. <u>Tank Labeling</u>: All tanks should be clearly labeled to identify their contents and other emergency information necessary if the tank were to rupture, spill, or ignite.

The Application for modification was submitted pursuant to Water Quality Control Commission (WQCC) Regulation 3107.C and is approved pursuant to WQCC Regulation 3109.

Please note that "When a plan has been approved, discharges must be consistent with the terms and conditions of the plan". Pursuant to Section 3107.C EPFS is required to notify the Director of any facility expansion, production increase or process modification that would result in a significant modification in the discharge of potential ground water contaminants.

Note, that OCD approval does not relieve EPFS of liability should EPFS operation's result in contamination of surface waters, ground waters or the environment.



Dear Mr. Bays:

The discharge plan GW-188-3 for the El Paso Hart Canyon #3 Compressor Station located in NW/4, Section 8, Township 31 North, Range 9 West, NMPM, San Juan County, New Mexico, is hereby approved under the conditions contained in the enclosed attachment. The discharge plan consists of the application and its contents dated June 16, 1995.

The discharge plan application was submitted pursuant to Section 3-106 of the New Mexico Water Quality Control Commission Regulations. Please note Sections 3-109.E and 3-109.F which provide for possible future amendments or modifications of the plan. Please be advised that the approval of this plan does not relieve El Paso Natural Gas Company of liability should the operations associated with this facility result in pollution of surface water, ground water, or the environment.

Please be advised that all exposed pits, including lined pits and open top tanks (tanks exceeding 16 feet in diameter), shall be screened, netted, or otherwise rendered nonhazardous to wildlife including migratory birds.

Please note that Section 3-104 of the regulations requires that "When a plan has been approved, discharges must be consistent with the terms and conditions of the plan." Pursuant to Section 3-107.C you are required to notify the Director of any facility expansion, production increase, or process modification that would result in any change in the discharge of water quality or volume.

Pursuant to Section 3-109.G.4, this plan is for a period of five (5) years. This approval will expire August 3, 2000, and you should submit an application for renewal six (6) months before this date.

The discharge plan application for the Hart Canyon #3 Compressor Station is subject to the WQCC Regulation 3-114 discharge plan fee. Every billable facility submitting a discharge plan will be assessed a fee equal to the filing fee of fifty dollars (\$50) plus the flat fee of six-hundred and ninety dollars (\$690.00) for Compressor Stations exceeding 1,000 Horsepower at site conditions.

The \$50 filing fee has been received by the OCD. The flat fee for an approved discharge plan has not been received by the OCD. The flat fee check should be submitted to the NMED - Water Quality Management through the NMOCD office in Santa Fe, New Mexico.

On behalf of the staff of the Oil Conservation Division, I wish to thank you and your staff for your cooperation during this discharge plan review.


### ATTACHMENT TO DISCHARGE PLAN GW-188-3 APPROVAL El Paso Natural Gas Company - Hart Canyon #3 Compressor Station DISCHARGE PLAN REQUIREMENTS

(August 3, 1995)

- 1. <u>Tank Berming</u>: All tanks that contain materials other than fresh water that, if released, could contaminate surface or ground water or the environment will be bermed to contain 1 1/3 times the capacity of the tank or 1 1/3 times the volume of all interconnected tanks.
- 2. <u>Drum Storage</u>: All drums will be stored on pad and curb type containment.
- 3. Spills: All spills and/or leaks will be reported to the OCD district office pursuant to WQCC Rule 1-203 and OCD Rule 116.
- 4. <u>Modifications</u>: All proposed modifications that include the construction of any below grade facilities or the excavation and disposal of wastes or contaminated soils will have OCD approval prior to excavation, construction or disposal.
- 5. Payment of Discharge Plan Fees: The six hundred and ninety dollar (\$690) flat fee shall be submitted upon receipt of this approval. The flat fee may be paid in a single payment due at the time of approval, or in equal annual installments over the five (5) year duration of the plan, with the first payment due upon receipt of this approval.
