The New Mexico Oil Conservation Division (NMOCD) has received and reviewed the above report, which is hereby accepted and approved with the following understandings and conditions:

1. All groundwater-monitoring wells will be gauged monthly, during 2006, for water levels and the presence or absence of PSH (phase-separated hydrocarbons).
2. Monitor wells MW-1, 2, 3, 11, and 12 will be sampled quarterly and analyzed for BTEX. Samples of these wells will be analyzed for PAH's annually.
3. Monitor wells MW-4, 7, 8, 9, 10, and 13 will be sampled annually and analyzed for BTEX. Sampling and analysis frequency for these wells will be changed to quarterly if contaminants of concern are observed.
4. Monitor wells MW-5 and MW-6 may be plugged, with cement slurry containing 3% to 5% bentonite, to the surface, and abandoned.

NMOCD approval does not relieve Plains Pipeline, L.P. (Plains) of liability should its operations at this site prove to have been harmful to public health or the environment. Nor does it relieve Plains of its responsibility to comply with the rules and regulations of any other governmental agency.

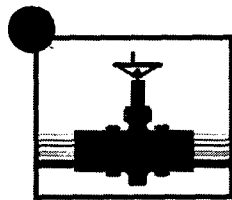

The New Mexico Oil Conservation Division (OCD) is in receipt of the Annual Monitoring Report, submitted by your consultant, Environmental Plus, Inc. for the Lea Pump Station located in the NW/4 of Section 28, Township 20 South, Range 37 East, NMPM, Lea County, New Mexico. Based upon the information provided in the report, the recommendations suggested by Environmental Plus, Inc. are approved subject to the following stipulation:

1. Monitoring wells MW-5 and MW-6 will not be abandoned but will remain in condition for annual monitoring until such time as all ground water under the site is remediated and the ground water monitoring can be discontinued.
