In addition to the January 25, 1999 letter (an attached copy is included) through routine housekeeping, an New Mexico Oil Conservation Division (NMOCD) representative inspected unlined surface impoundment's at the five locations that are referenced above. The NMOCD has not received a response from your company to the January 25, 1999 letter.

JPH is hereby ordered to submit the following information:

- 1.) A remediation plan and a pit closure for each of the sites referenced above.
- 2.) Provide vertical extent for each site, which shall include TPH, BTEX and Chloride analysis all per EPA SW-846 protocols.
- 3.) Please notify NMOCD 48 hours prior to sampling so we may witness and/or split samples.
