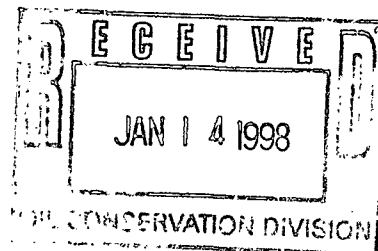

New Mexico Oil Conservation Division (NMOCD) is in receipt of the above referenced subsequent report. Please note the report is marked as an initial report, thus indicating ROC still requires investigation and remediation.

After reviewing the location of the leak it appears the leak was close to the city of Lovington's fresh water well field. Please submit to this office within 30 days of receipt of this letter a site assessment of the area pursuant to the NMOCD Guidelines, an action plan to determine the contaminants of concern, the vertical extent of the contamination, and a work plan for the remediation of the affected area.

Upon receiving this plan NMOCD will approve as is or with conditions.
