The New Mexico Oil Conservation Division (OCD) has completed a review of Shell Oil Company's (SOC) January 6, 1995 "ANDERSON RANCH STATION, LEA COUNTY, NEW MEXICO". This document contains a final reporting of the remedial actions performed at SOC's Anderson Ranch crude pump station and requests final closure of the remedial actions.

**SOC's request for final closure is approved.** The OCD considers the investigation and remedial actions to be completed in accordance with the regulations in effect at the time of closure.
