1. The City of Lovington and OCD shall be notified of all significant activities during this project. All reports required by OCD shall also be copied to the OCD District office and the City of Lovington.

2. Any waste removed during the project shall be disposed of at an approved OCD site.

3. Pure will notify the OCD Santa Fe office, OCD District office and the City of Lovington at least 72 hours in advance of all scheduled activities such that there is adequate opportunity to witness the events and/or split samples during normal business hours.

4. Pure shall submit an interim report by January 15, 2004 or sooner, showing the final sidewall and bottom hole sampling results, with documentation and photos. Pure shall receive OCD approval before back filling any excavated area.
