The New Mexico Oil Conservation Division (OCD) has reviewed Plains Pipeline, L.P. June 26, 2006 "SOIL CHARACTERIZATION REPORT AND REMEDIATION PLAN" on the LIVINGSTON LINE BOB MCCASLAND RELEASE SITE, NE1/4 SW1/4 OF SECTION 3, TOWNSHIP 21 SOUTH, RANGE 37 EAST OF LEA COUNTY, NEW MEXICO prepared on behalf of Plains Pipeline, L.P. by Environmental Plus, Inc. (EPI). This document contains Plains Pipeline, L.P.'s evaluation of soil analysis and a proposal for closure of the excavated portion of the subject release site. Since discovery of the release in July 2001 and subsequent ongoing remediation efforts, approximately 11,445 yd³ have been excavated, at least 20 soil borings and at least 11 monitor wells installed. These efforts have resulted in reduced BTEX and TPH concentrations. Chloride concentrations were not at issue with this release. As the analysis indicate BTEX and TPH to be still elevated throughout the site, NMOCD will reevaluate the proposed closure of the excavated area after submittal of the 2006 Annual Report which is due in April 2007.

NMOCD acceptance of this remediation plan does not relieve Plains Pipeline, L.P. of liability should its operations at this site prove harmful to public health or the environment. Nor does it relieve Plains Petroleum, L.P. of its responsibility to comply with the rules and regulations of any other federal, state, county or local governmental agency.

Dear Mr. Olson,

Environmental Plus, Inc.(EPI), 2100 Avenue O, Eunice, New Mexico, on behalf of E.O.T.T. Energy Pipeline, Midland, Texas submits this written notification of ground water impact due to a crude oil leak on the Livingston Line 4" Bob McCasland (E.O.T.T. reference #2001-11043), in the Unit Letter N (SW¼) of Section 3, T21S, and R37E in excess of 20 NMAC 6.2.3103, i.e., "Non-aqueous phase liquid shall not be present floating atop or immersed within ground water, as can be reasonably measured." This submittal follows the immediate verbal notification made on August 22, 2001 and is consistent with the notification requirements of 19 NMAC 15.116. A location map is attached.

Distribution of the crude oil source term at the site is currently being assessed and there are no domestic, agricultural, or public supply wells within 2000' of the site.
