**General Description of Remedial Action:** Delineated vertical and lateral extent to below

NMOCD guidelines. Soil boring demonstrates impact probably stopped before reaching groundwater. Chlorides declined from 2316 ppm at 25' bgs to 550 pm at 45' bgs. Hauled high impacted soil to Sundance and blended fresh soil to below NMOCD guidelines. Installed compacted clay liner as a barrier to vertical transmissivity and backfilled. This site is no longer a junction and does not require a box.
