**General Description of Remedial Action:** Delineated vertical and lateral extent. Vertical

extent demonstrated chlorides dropped from 2300 ppm at 8' bgs to 1500 ppm at 14'. This delineation indicates impact probably stopped before reaching groundwater. High impact soil was hauled to a permitted disposal facility. The remaining soil was blended with fresh soil to below NMOCD guidelines and used as backfill. Installed compacted clay liner as a barrier to inhibit vertical transmissivity. A water tight junction box was installed and backfilled.






