In a New Mexico Oil Conservation Division (NMOCD) letter dated February 9, 2006 the above-referenced proposal was deemed insufficient to qualify as a Stage 1 Abatement Plan. After conversations between Mr. Bob Allen of Safety & Environmental Solutions, Inc. and myself, the NMOCD has further determined that the proposal will be accepted as a delineation work plan for the site. This work plan is hereby approved and Mack Energy Corp. (Mack) may begin the work described therein. After the investigations and delineations are complete, Mack shall submit a combined Stage 1/Stage 2 Abatement Plan according to the requirements set forth in 19.15.1.19 NMAC.

Such Stage 1/Stage 2 Abatement Plan shall be submitted by April 15, 2006.
