On February 11, 2005, you requested a meeting with Dynegy and LA personnel regarding questions you have pertaining to the remediation of the sites. After repeated attempts to schedule a meeting (2/14/05, 2/18/05 and 4/11/05), we have not been able to receive a response from you regarding a time and date.

Several of the sites have open excavations, pending closure approval, and present a safety hazard. Dynegy respectfully requests that closure be granted by the NMOCD for the above referenced sites.



2. Dynegy shall re-evaluate the ranking score and re-submit the plan accordingly.


