#### Dear Ms Haynes:

OCD is in receipt of the September 15, 2005 ICP for the K-4 leak BD SWD system. The plan is hereby approved with the following conditions:

- 1. A Corrective Action Plan (CAP) shall be submitted no later than January 13, 2006.
- 2. Notify the OCD Santa Fe office and the OCD District office at least 48 hours in advance of all scheduled activities such that the OCD has the opportunity to witness the events and/or split samples during OCD's normal business hours.
- 3. Within 10 days please provide an explanation why ROC is submitting a CAP 19 months after the spill occurred? In the spirit of cooperation, OCD encourages ROC to be more responsive to these type of releases. It appears that 40 barrels has migrated down 80 feet in this amount of time. As discussed during our recent technical meeting, OCD would like to see ROC develop an emergency response plan for leaks and spills and submit that plan to OCD for approval.

Please be advised that NMOCD approval of this plan does not relieve ROC of Responsibility should their operations fail to adequately investigate and remediate contamination that pose a threat to ground water, surface water, human health or the environment. In addition, NMOCD approval does not relieve ROC of responsibility for compliance with any other federal, state, or local laws and/or regulations.
