The New Mexico Oil Conservation Division (NMOCD) has received and reviewed the above report. We find that additional information is required by us to properly evaluate the report. This information includes, but is not limited to, the following:

1. Extent of the current excavation, including total volume of soil removed and currently stockpiled on-site.
2. A form C-141 detailing the original release.
3. A plan of action for the remainder of the contaminated soil at the site.
4. Plains' plans for further delineation at the site.

The NMOCD understands that a work plan is in process that may provide further information as to what Plains intends to do at this site. This work plan is to be submitted to the NMOCD by May 31, 2006.

Ed and Pat,

As per our discussion on 12/19/05, Plains has discovered impact to groundwater at a release located in the SW/4 of S26, T21S, R37E, which occurred on 11/10/2000 on a 4" steel pipeline. During the installation of a monitoring well at the site location, a small amount of PSH was noticed on the drill tool at the groundwater interface and the water appeared to have a slight sheen of PSH. It is anticipated that the PSH impact is minimal and that this well will only have a small amount of measurable product after it has been properly developed. 2 additional monitoring wells were installed at the site during this drilling event but did not have any noticeable PSH before the wells were developed.

The landowner is Del Rose Scott and notification has been made to Gary Scott regarding the discovered impact.

The Plains site name is DS 4" Hugh Gathering and the Plains reference leak number is 2000-10807.
