Dear Sir:

On July 26, 1993, the New Mexico Oil Conservation Division (OCD) sent you correspondence by certified mail requesting information related to the illegal transportation and disposal of oil field waste at the unpermitted Johnny Reid disposal site located in the SW/4, NW/4 of Section 23, Township 23 South, Range 28 East, NMPM, Eddy County, New Mexico. The OCD has a record of Saulcon Construction receiving this correspondence. To date the OCD has received no reply from your company.

The OCD considers your failure to respond an admission that Saulcon Construction was involved in the illegal transportion of oil field wastes to this site for disposal.

Upon review of the correspondence from other parties in this case and a site inspection, the OCD has approved the closure of the unpermitted Johnny Reid disposal site located in the SW/4, NW/4 of Section 23, Township 23 South, Range 28 East, NMPM, Eddy County, New Mexico.

The OCD would like to remind Saulcon Construction that the transportation and disposition of all oil field wastes associated with any well site must be authorized by the OCD. Failure to receive authorization for the transportation and/or disposal of oil field wastes is a violation of OCD rules and the New Mexico Oil and Gas Act. The site location, waste content and transporter information provided by the responsible parties regarding disposal activities at this unpermitted facility will remain on file with the OCD. Further violations could subject Saulcon Construction to civil penalties.

In order to avoid future occurrences of this nature, it is incumbent upon Saulcon Construction to contact the OCD to receive approval for the transportation and disposition of any oil field wastes associated with an oil and gas well site or sites.



This letter contains the information you requested in your letter concerning the oilfield waste RB Operating disposed into a pit owned by Johnny Reed located in the SW/4,NW/4 of Section 23, Township 23 South, Range 28, NMPM, Eddy County, New Mexico.

In general there were four (4) wells located on the Reed ranch that we took the dry drill cuttings from and deposited into Mr. Reed's pit. These wells were drilled with closed pit systems (no reserve pits) to preserve sensitive farmland and pasture that we were drilling on.

All the wells were drilled and completed from March-July 1990 and only dry cuttings (no fluid) were deposited in the pit during that time frame. The material was hauled in all 4 cases by M&M Rental Tools located at 5600 W. Carlsbad Highway, Hobbs, New Mexico, 88240.

We (RB Operating Co.) did not believe it was necessary to notify the OCD at the time because the cuttings that were deposited in Mr. Reeds pit were dry and did not contain any hazardous chemicals in reportable amounts. The cuttings were placed there at Mr. Reed's request.

The OCD has no record of RB Operating requesting or receiving approval to transport or dispose of oilfield wastes at this location.

Therefore, RB Operating is hereby required to provide the OCD with the following information related to the above referenced facility:

- The lease name, well number and legal location of wells from which oilfield wastes were removed for disposal at the Johnny Reid site.
- 2. The volume and type of waste removed from each well site.
- 3. The dates on which these wastes were removed from each well site for disposal.

- 4. The name and address of the company or individual that transported the wastes from each site.
- 5. Any documentation which shows authorization to transport or dispose of oilfield wastes at the Johnny Reid site.

Dear Mr. Anderson:

Early in 1990 RB Operating Company notified me that they were going to drill 4 oil wells in N/2 523-23-28. All of these wells were in irrigated farmland that I own and operate. RB Operating agreed to use steel tanks to contain the mud and water if I would provide a place to move the waste to. I have a plot of land that is very rocky and there is an rock quarry that was used in the 1950 for road construction in the area here. RB Operating drilling officials inspected the pit and it was decided that it was adequate to use to place the material in. RB Operating used the pit to place 4 wells into. As drilling spread onto farms around mine, Bird Creek Resources drilled several wells on farms North and West. However, the tailings from these wells were put in plastic lined pits in the ground and then moved as the material dried.

H & H Excavating moved the material for Bird Creek Resources and Saulcon Construction moved the materials for RB Operating.

The Water table stands at apporximately 60 feet. None of the wells in these area are used for human consumption. Tests by NMSU made in the 1980's indicated that this water is unfit for irrigation. However, we do use it to supplement irrigation water from the Pecos River. The Pecos River flows to the South about 1.5 miles to the East of the pit in question. The nearest public water supply is the City of Loving wells approximately 10 miles west of here.

RB Operating has conducted water tests and that information is available from their Environmental Department at Midland Texas. They are using some of the wells listed as test sites.

- 1. 8" irrigation well ownly by Johnny Reid 300 feet west
- 2 Domestic wells (inoperative at present) owned by Edwin Collins, 126 Donaldson Farm Road, Loving, NM Used only for grass yard and livestock.

- 3. 8" irrigation well owned by Dorothy Queen, East Ash Road, Loving NM, 800 feet West.
- 2 Domestic wells owned by Johnny Reid, approximately 1,000 feet N.E. of pit, used only for grass, trees and livestock.
- Domestic well owned by Claude Estes, 221 E. London Road, Loving NM, used for garden, grass and trees, 1900 feet North.

I might add that at no time prior to receiving your call, was I ever aware that I was in violation of any regulations. All of the companies involved assured me that the waste could be put in my pit without any problems. I assumed that OCD knew from the beginning that the material was being moved and knew where it was going. In May 1993, Mr. Dean Strickland of H & H Excavating told me he had OCD (Artesia) approval to move a pit to my pit if it came from private land and was going on to private land.

Dear Mr. Reid:

On June 23, 1993 the Director of the Oil Conservation Division (OCD) was notified of an unpermitted oilfield waste disposal facility located in the SW/4 NW/4, Section 23, Township 23 South, Range 28 East, NMPM, Eddy County, New Mexico. On that same day the OCD Artesia District office ordered you, as operator of the facility, to cease accepting wastes.

Pursuant to 70-2-12.B.(21) NMSA 1978, authority is vested in the OCD to make rules and regulations "to regulate the disposition of non-domestic wastes resulting from the exploration, development, production or storage of crude oil or natural gas to protect public health and the environment:". OCD Rule 711 (enclosed) requires oilfield surface waste disposal facilities to be permitted prior to operation. Your facility is unpermitted and has been accepting drilling wastes in violation of OCD Rules.

In order to evaluate the impacts of your operation, you are required to provide the following information to the OCD:

- 1. A list identifying all wastes received at the facility.
- 2. A list identifying all generators, with addresses, that disposed of any wastes at the facility.
- 3. A list identifying all transporters that hauled any wastes to the facility.
- 4. Water quality information at the facility. This will include the depth to ground water, the ground water quality, the distance to and public and/or private water wells and the distance to the nearest surface water body.

If you feel the site is appropriate for oilfield waste disposal , you must apply for a permit to construct and operate the facility. If it is determined by the OCD that the site is not appropriate for the disposal of oilfield wastes, the OCD may require removal of the wastes and remediation of the site.

Please provide the above required information to the OCD by July 9, 1993.
