The New Mexico Oil Conservation Division (NMOCD) has received and reviewed the report shown above submitted by Basin Environmental Service Technologies, LLC on behalf of Plains Marketing, L.P. (Plains).

The remediation plan as shown in the report is hereby approved with the following conditions and understandings:

- 1. The report states that "Plains proposes to excavate the hydrocarbon-impacted soil at the release point to a depth of approximately 12 feet bgs." The NMOCD assumes this to mean 12 additional feet below the bottom of the current excavation in the area of the initial release, since earlier in the report it is stated that the site has already been excavated to a depth of 12 feet bgs.
- 2. The installation of a 40-mil poly liner in the bottom of the excavation, to prevent the migration of contaminants left in place below the liner, is approved. Also, as stated in the report, this liner will extend a minimum of four feet beyond the edges of soil impacted above NMOCD remedial thresholds. Installation shall not commence until the NMOCD receives a report showing the sampling results of the sides of the excavation.

- 3. The report recommends the plugging and abandonment of monitor wells upon the completion of four (4) consecutive sampling events that result in groundwater testing below NMOCD regulatory standards. This recommendation is not approved at this time. This may be reconsidered by the NMOCD upon a formal report showing the results of the four consecutive sampling events and a request to plug the monitor wells.
- 4. Plains has not adequately delineated the horizontal extent of the contamination at this site. If the proposed additional horizontal excavation activities do not completely delineate the horizontal extent of the contamination, then further delineation will be required until the contamination at the site is completely delineated.
- 5. All stockpiled soils will be disposed of at an NMOCD-approved facility.
- 6. The NMOCD Artesia District Office shall be notified 72 hours in advance of any sampling event.

NMOCD approval does not relieve Plains of future liability should its site investigation and remediation efforts prove inadequate to protect human health and the environment. Nor does it relieve Plains of its responsibility to comply with the rules and regulations of any other federal, state, county or local governmental agency.
