Soil analytical were as follows; benzene - 1.4 mg/kg, total BTEX - 81.6 mg/kg, TPH - 6270 mg/kg. One groundwater sample was collected with analytical results as follows; benzene - 3,200ppb, toluene - 2,500 ppb, ethylbenzene - 2,500 ppb, total xylenes - 28,000 ppb.

A RECON® survey was conducted and five soil-gas samples and five groundwater samples were collected in probe holes surrounding the pit. All samples were collected and analyzed using a laboratory-grade gas chromatograph by Philip Environmental's RECON® System.. No BTEX constituents were detected.
