Gentlemen:

Reference is made to your request from your Hobbs office on Form C-103, dated October 19, 1955, to cancel NSP-119 and DC-186 on your F. W. Kutter "C" Well No. 1 in the SE/4 NE/4 of Section 18, Township 19 South, Range 37 East, Lea County, New Mexico. DC-186 was issued March 10, 1955 for dualling the Eumont Gas formation and Monument Oil formation. NSP-119 was issued on April 20, 1955 to form a unit of the S/2 N/2 of Section 18 for 160 acres in the Eumont Gas Pool.

Effective this date, NSP-119 and DC-186 are cancelled per your request, due to mechanical difficulties in the dualling process of this well.

Gentlemen:

Reference is made to your application for approval of a 160-acre non-standard gas proration unit in the Eumont Gas Pool consisting of the following acreage:

Township 19 South, Range 37 East, NMPM
S/2 N/2 of Section 18

It is understood that this unit is to be ascribed to your F. W. Kutter "C" Well No. 1, located 1980 feet from the North line and 660 feet from the East line of Section 18, in the SE/4 NE/4 of Section 18, Township 19 South, Range 37 East, NMPM, Lea County, New Mexico.

By authority granted me under provisions of Rule 5, Section (b)-6 of the Special Rules and Regulations for the Eumont Gas Pool, as set forth in Order R-520, you are hereby authorized to operate the above described acreage as a non-standard gas proration unit, with allowable to be assigned thereto in accordance with pool rules, based upon the unit size of 160 acres.
