
**Cause of Release:** On January 8, 2020, Enterprise discovered a release of natural gas and natural gas liquids on the Lateral 6A-19 pipeline. An estimated ten (10) barrels of fluids were released to the ground surface. The pipeline was blown down, depressurized, locked out and tagged out. No washes were affected. The released fluids are being recovered as much as practicable. Repairs and remediation are in the scheduling process. A third party closure report will be submitted with the "Final C-141."
