
Cause of Release: On February 27, 2020, Enterprise discovered a release of condensate from a riser on the Lateral 2C-60 pipeline. No washes were affected. An area of approximately 2 feet in diameter was impacted by released fluids. Remediation began on March 4, 2020. Enterprise determined the release reportable per NMOC D regulation on March 5, 2020, due to the volume of impacted subsurface soil. A third party corrective action report will be submitted with the "Final C-141."
